The following list of renter's responsibilities should be followed during rental:

- The pool and premises, including keys, shall be under the control of the Vidalia Recreation Department, which shall have the right to enter the premises at all times during the period covered by the lease.
- No lessee shall alter the appearance or make changes to any portion of the facility without the consent of VRD.

- Renter is only entitled to the hours specified when reservation is made/confirmed. Set
 up and clean up is considered part of the rental. All trash must be placed in receptacles
 and all food, etc. must be swept and placed in the garbage.
- Outside food is permitted but must be pre-prepared.
- The pool may not be subleased.
- Table decorations are allowed (no tape or thumb tacks on walls, etc.) but must be cleaned up by renter.
- Absolutely NO ALCOHOLIC BEVERAGES, ILLEGAL SUBSTANCES, OR SMOKING are allowed on or around the facility or in the parking area. Persons who have been drinking are not allowed on or around the premises.
- Tables should not be moved from their current location without approval and if approved then they must be moved back to original location.
- Renters are responsible for facility damages and will be expected to pay for any necessary repairs.

Renters are responsible for ensuring that their guests are aware of the following rules prior to visiting the facility:

- Children under 12 must be accompanied by a guardian (16 or older).
- Parents/Guardians are responsible for the supervision of their children at all times.
- Certified lifeguards are on duty at all times.
- Life guards are responsible for ensuring safety and responding to emergencies, not child supervision.
- Lifeguards have final authority on all safety rules.
- Proper swimsuit and swim attire are required. No cutoff shorts, no thongs allowed, etc. No exceptions will be made.
- Swim diapers are required for all diaper dependent guests. Swim diapers are sold at the concession stand if needed.
- No outside toys or inflatables are allowed inside the park.
- Bathers are allowed to wear US Coast Guard approved flotation devices only.
- Grills or any other cooking equipment are not allowed on pool property. This includes the parking lot area. No exceptions.
- Music devices of any kind are not allowed on pool property. This includes boom boxes, etc. There is no access to a sound system at the facility.
- If inclement weather arises, the facility will be closed based upon the reading of the lightning detector by a lifeguard.
